Networks Northwest budget report ending 2/28/18

Darla Rowland presented the budget report for the month ending February 28, 2018. Expenditures are at 49%. The Small Business Development Center (SBDC), which is on a January – December year, has new program year funds on the report. The report also reflects increases in Wagner-Peyser Employment Services, Reemployment Services and Eligibility Assessment (RESEA), RESEA Work Based Training, and WIOA Statewide Activities. Seven companies completed Skilled Trades Training Fund (STTF) training for a year to date total of \$147,457.

Northwest Michigan Works! Inc. budget report ending 2/28/18
