The report reflects 11 months of the fiscal year and 2 months of the Workforce Investment Act (WIA) funds, which are on a July to June year. The WIA Adult and Dislocated Worker funds come in two allocations; a three month allocation in July and the remaining 9 months in October. The report also includes a Foster Care Summer Youth program that operated through Michigan Works during the summer. There was discussion on modifying the identification of new funds and changes in funding levels on the budget reports in FY15.
