They stressed the organizational partnerships that are involved in these various activities. Problems and shortcomings were then addressed, including but not limited to: lack of scale; decreasing funding; inadequate or outdated policy at federal and state levels; absence of one or more large, dominant employers in the region to provide financial and other leadership.

Staff presented four questions for board discussion, and considerable time was given for board input.

- How can we get the private sector much more involved?
- How can we scale up our successful activities?

Numerous ideas were presented by board members as a result of the discussion, and staff will follow up.
