Some board discussion regarding the future of the program with a new governor incoming.

Regional Childcare Shortage & Action Plan

McCauley stated that child care is a workforce development issue as it impacts the how employers are able to attract and retain talent. He thanked the MEDC for supporting the work done by PSC to date and stated that a final report would be available in the coming weeks. Board discussion ensued focused on the importance of the issue, but the difficulty of addressing it.
