Call to Order and introductions

G. Fedus, Chair, called the meeting to order at 5:01 p.m. and welcomed everyone to the Zoom meeting.

M. McCauley provided additional details to the information provided within the CEO Report. He also thanked the Board for their participation and positive comments regarding his most recent performance review.

Motion by B. Kennis, supported by R. Schmidt, to accept the Networks Northwest Budget report and Northwest Michigan Works! budget report as of 10/31/20 as presented. Motion passed unanimously.

2020 CEO Evaluations

S. Peters provided details surrounding M. McCauley's 2020 CEO Performance Review. She stated that the scores and comments from both the Board and staff were overwhelmingly positive. She also noted the targeted areas for improvement in 2021, including increasing communication to staff and board member participation. S. Peters also noted that M. McCauley declined any discussion regarding a salary adjustment based on performance. Brief discussion ensued.

2021 Networks Northwest Board Meeting Schedule

M. McCauley provided the proposed 2021 Board meeting schedule. He stated the reasoning for the tentative meeting in October was to provide options in case health restrictions on gatherings continue.

Motion by M. Cain, supported by B. Hundley, to accept the 2021 Networks Northwest Board Meeting Schedule. Motion passed unanimously.

2021 Networks Northwest Board Attendance Policy

G. Fedus presented the Executive Committee's proposed Board Member Attendance Policy. M. Cain suggested that a firmer policy be pursued and volunteered to work with staff on a proposal for the Board to instead consider at their next meeting. Brief discussion ensued and there was general agreement to revisit the subject at the February meeting.

CEDS Strategy Committee

M. McCauley stated the relationship between Networks Northwest and the Economic Development Administration, including the required regular authoring of the "Comprehensive Economic Development Strategy (CEDS)." He stated that the CEDS is done in coordination with economic development and businesses leaders from throughout the region, but asked if the Board would consider to form a special 2021 subcommittee to help assist and inform the process as well.

Motion by L. Leedy, supported by J. Barnard, to approve the Comprehensive Economic Development Strategy (CEDS) as presented. Motion passed unanimously.

WIOA/TIA Policy Compliance

T. Vandercook presented a variety of local policies to be reviewed and approved as required by the Talent and Investment Administration (TIA). He stated while all the policies presented were revised to some degree, most of the proposed edits are considered mainly insubstantial. M. McCauley added that policy revisions of such a degree used to be considered the role of the CEO, but the State of Michigan would prefer otherwise moving forward. He also explained that it is likely that additional policies will be presented at both the February and April meetings.

Motion by B. Kennis, supported by M. Cain, to approve the Workforce Innovation Opportunity Act (WIOA) Policy Compliance as presented. Motion passed unanimously.

MI Works Association Board Appointment

M. McCauley explained some of the governance changes occurring at the Michigan Works State Association. He stated that the changes include having two representatives from each of the State's sixteen talent districts, including each agency's Director and an additional representative of each Board's choosing.

Motion by S. Perdue, supported by S. Peters, to approve Matt McCauley and Stacie Bytwork's appointment to the MI Works Association Board of Directors. Motion passed unanimously.
