## TC-TALUS Long-Range Transportation Plan Available for Public Comment

TRAVERSE CITY, MI—The Traverse City Area Transportation and Land Use Study (TC-TALUS) is seeking public input on its draft 2035 Long-Range Transportation Plan. The plan is a comprehensive analysis of current and future transportation options in Traverse City and nine surrounding townships.

Copies of the plan are available at the Acme, Blair, Elmwood, East Bay, Garfield, Green Lake, Long Lake, Peninsula, and Whitewater Township halls. The plan is also available at the Grand Traverse and Leelanau County Road Commission offices, the Grand Traverse County and Traverse City Planning Department offices, the Bay Area Transportation Authority office, and the Northwest Michigan Council of Governments office.
