I'm sorry for the delay on my response. In regards to Michelle Hammond:
Michelle completed Mental Toughness and was accepted into the YouthBuild program on September 21, 2012. Michelle attended regular programming on September 24 and September 25, 2012. She had a doctor's appointment on September 26 and was excused for the day. Michelle did not show up nor call in on the last two days of the week. Calls to her family's phone number went unanswered. I contacted Michelle's stepmother on October 2. She informed me that Michelle, who was sixteen weeks pregnant at the time, had miscarried her baby the previous weekend. According to her stepmother, Michelle as living either with friends or her mother. She did not have a phone number for me to contact Michelle. I left a message with Michelle's father asking him to please call me or have Michelle call me on October 4, and I sent a text message to Kelly Hammond (stepmother) on October 11. Kelly said that Michelle had been kicked out of the home the previous week for failing to follow house rules. She did not know how to get a hold of Michelle.
