The event will include a keynote presentation by Northwest Michigan Works! Chief Operating Officer Janie McNabb. She will discuss the cause and effect of the jobs gap in northwest Michigan. There will also be a panel featuring employers from healthcare, hospitality, and manufacturing. They will talk about issues in retaining and finding talent and how they are addressing those needs.

Following the keynote and panel presentations there will be an opportunity for audience discussion.
