#### **Call to Order and introductions**

Sue Peters, Vice Chair, called the meeting to order at 5:35 p.m. and welcomed everyone to the meeting.

#### **Networks Northwest Minutes of February 13, 2017**

#### **Executive Committee report**

S. Peters gave a short report on the Executive Committee's last meeting. The primary topic of discussion was the Beaver Island Lighthouse property, and that discussion was held in closed session.

She also reported that the committee is recommending that the Chamber of Commerce at-large board seat be filled with the appointment of Stacie Bytwork of Manistee Chamber, replacing Bill Tencza who retired.

Motion by M. Cain, supported by S. Perdue, to approve the at-large board seat recommendation for Stacie Bytwork. Motion passed unanimously.

She also reported that the committee reviewed how the CEO transition process is going, and that everything seems to be going very well and on schedule.

#### **Finance Committee Report**

S. Perdue, Committee Chair, presented the Finance Committee report. Steve briefly presented all the information the committee had reviewed and stated that the budgets and expenditures are all in good order. Questions were answered.

Motion by S. Perdue, supported by R. Schmidt, to accept both the Networks Northwest and NW Michigan Works! Inc. FY17 Budget reports of 2/28/17as presented. Motion passed unanimously.

# **Quality Assurance Committee report**

C. Welch gave the committee report in place of J. Korthase. He reviewed each item individually.

a. Michigan Works! Dashboard

Motion by C. Welch, supported by B. VonVoigtlander, to accept the Michigan Works! Dashboard. Motion passed unanimously.

b. Internal monitoring reports summary

Motion by C. Welch, supported by M. Smith, to accept the internal monitoring report. Motion passed unanimously.

c. External monitoring reports

Motion by C. Welch, supported by D. Parkes, to accept the external monitoring report. Motion passed unanimously.

d. STTF dashboard

Motion by C. Welch, supported by C. Carland, to accept the STTF dashboard. Motion passed unanimously.

#### **One Stop Operator**

E. Wood reviewed the process that has taken place to meet the federal requirement for a contracted One Stop Operator (OSO). The RFP had to be put out a second time because there were no responses the first time. However, one bid was received the second time. She reviewed the specific tasks the OSO is being asked to perform, and reminded board members that, because we operate all our programs with in-house staff, there is very little role for a traditional OSO in our region. She reviewed the proposal that was made by Traverse Bay Area Intermediate School District and showed the board that the proposal meets all the requirements and is very reasonably priced.

Motion by R. Smith, supported by M. Cain, to approve the One Stop Operator bid and to contract with Traverse Bay Area Intermediate School District for a one-year period, renewable for up to three years, effective July 1, 2017. Motion passed unanimously.

## Strategic discussion topic: Adult Education

- a. Prosperity Index Committee report
   Committee Chair, K. Osborne presented some general data that was discussed by the committee, in order to introduce the topic.
- Presentation (E. Wood; T. Vandercook; C. Nelson)
   Staff members gave a thorough presentation on the history and current operation of the Adult Education Program.
- c. Questions for board Board members were asked to discuss several key questions related to adult ed programming in order to provide insight and feedback for the staff. Considerable discussion was held in smaller groups and group reports were made.
- d. WIOA Title II grant application
  E. Wood reviewed again, from the initial presentation, that the State Aid funds for Adult Education are combined with the WIOA Title II funds for Adult Education in order to deliver one comprehensive, integrated program for the region. She reviewed the Title II grant application which was in the board packet.

Motion by M. Groleau, supported by J. Barnard, to approve the WIOA Title II grant application and to indicate that it is fully aligned with the comprehensive Adult Education program in the region. Motion passed unanimously.

Two board members Rachel Johnson & Beth Holmes-Bozung were recognized by E. Wood and the board for being selected as leading business women in the Grand Traverse area.
