#### Finance Committee Report

S. Perdue presented the Finance Committee report. He stated that the committee didn't meet before the meeting. He went over the budgets and expenditures are all in good order. Questions were answered.

a. Networks Northwest budget reports of 12/31/17

Motion by S. Perdue, supported by D. Parkes, to accept the Networks Northwest budget report of 12/31/17 as presented. Motion passed unanimously.

b. NW Michigan Works! Inc. budget reports of 12/31/17

Motion by S. Perdue, supported by C. Carland, to accept the NW Michigan Works! Inc. budget report of 12/31/17 as presented. Motion passed unanimously.

M. McCauley informed the board that the annual notification of audit letters were available for anyone that would like a copy.

#### U.S. Department of Commerce – EDA Grant Application

Sarah Lucas presented information on the U.S. Department of Commerce- Economic Development Administration. She stated that EDA has increased the amount that Networks Northwest is eligible to apply for, and has moved Networks Northwest to a three-year grant cycle. The total grant amount, if awarded, would be \$210,000, including local match of \$90,000.

To process the application, the EDA requested that the Networks Northwest Board to authorize the NWMCOG Board Chair as the designated signatory for the application, award, and related documents; and to commit local match dollars in the amount of \$30,000 annually for the next three years, totaling \$90,000. Local funds are designated for this use.

"The governing body of Northwest Michigan Council of Governments, dba Networks Northwest, authorizes Chris Christensen, NWMCOG Board Chair, to act in behalf of this entity to sign and submit grant applications and related documents for the US Department of Commerce's Economic Development Administration Partnership Planning Program.

The governing body of Northwest Michigan Council of Governments, dba Networks Northwest, authorizes and certifies the Northwest Michigan Council of Governments dba Networks Northwest to make available no less than thirty thousand dollars (\$30,000) annually for the next three years, totaling ninety thousand dollars (\$90,000), for the purposes of cash match to the 2018 US Department of Commerce- Economic Development Administration Partnership Planning grant."

Motion by M. Cain, supported by D. Smallegan, to approve the U.S. Department of Commerce – EDA Grant Application as stated above. Motion passed unanimously.

#### Strategic discussion topic: 2018 Networks NW Board Meetings

Sarah Lucas and Matt McCauley led an instant surveying exercise with board members that provided insight on what topics and meeting format are preferential to the Networks Northwest Board in 2018.
