Description from previous plan:

Pleasanton Township, with a population of 817, is home to many recreational opportunities that take advantage of recreational sites and natural features within the community. Playground equipment, a ball diamond, and a picnic area exist at the Township Hall, three public access sites on Bear Lake, and the open space at the Township park on Lakeside Ave are all areas for recreation. Additionally, there is public access on Glovers Lake to the north in Township. The State of Michigan owns 2,164 acres of the township's land, and the Grand Traverse Regional Conservancy holds 1,428 acres of land for recreation and other conservation purposes which provide multi-user trails, wildlife viewing, and general enjoyment of nature. Recreational opportunities are plentiful. Part of the recreational experience in the Township includes the visual corridors where people can look over the vistas and view Bear Lake, state forest lands, and perhaps, if they are lucky, an occasional bald eagle. Pleasanton's most prominent trail connection is the west end of snowmobile Route 386 that follows Lumley Road east from US-31 toward Springdale Township. It joins the 213-mile-long Route 3 at the end of its 9-mile run, establishing connectivity among five counties stretching from Leelanau in the north to Newaygo in the south. The Arcadia Dunes Preserve biking and hiking trail grazes the northwest corner of the Township, and the preserve itself extends inland even further.

The open spaces of Pleasanton Township provide an aesthetic beauty which acts as the backdrop for recreational assets derived from the Northern shores of Bear Lake to the forested lands of the Pere Marquette State Forest to the east, and Grand Traverse Regional Land Conservancy land holdings in the north.

Access to Bear Lake at various public road ends, and Township owned properties provides for kayak and canoe access as well as areas for fishing and picnicking. The DNR Boat Launch along the northwestern shore of the lake is one of only two public launches on Bear Lake.

Snowmobile Trails and a trailhead adjacent to the Township Hall are the furthest west designated trail locations within Manistee County. These trails are important to the region, and can serve as sites for future trail connections to the communities of Arcadia, Bear Lake and Onekama.



- For regional authorities, describe the relationship between the authority and the recreation departments of the participating communities. Provide the Articles of Incorporation for the authority."

Goals & Projects

Prior to your community's discussion with Networks Northwest, please review the goals and projects from the previous plan. 1. Goal: Develop multi-use trails that are connected to a County wide trail system PROJECTS:

County-wide Trail System Collaboration:

- Continue to work collaboratively in developing the County wide trail system Equestrian Trail:
 - Work with the Conservancy to develop an equestrian trail system that allows for horseback riding, horse carts, and camping with horse trailer

Safe Crossing:

- Improve safety for trail users by developing safe crossing points on major road. Snowmobile Trail:
- Ensure a well connected snowmobile trail throughout the Township. Trail that encircles Bear Lake:
 - Develop a trail that circles Bear Lake including mile markers to help measure distance.

2. Goal: Improve the use of Township parks.

PROJECTS:

Township Hall Park:

• Improve the park facilities at the Township Hall Park including updating the lighting at the sports field, develop an outdoor restroom, provide frost fee drinking water, create a trail head with signage for snowmobile use and other multi-use trail users.

Lakeside Avenue Township Park:

• Develop restroom facilities at the Lakeside Avenue Township Park.

Lakeside Park:

• Install and improve playground equipment and picnic tables at Lakeside Park.

3. Goal: Create and improve access opportunities to Bear Lake.

PROJECTS:

Butwell Road End Land Acquisition:

• Purchase adjacent land to the Butwell Road access to Bear Lake in order to develop a new park area complete with restrooms and a picnic area.

All Access Points to Bear Lake:

• Install adult porch swings at all the access points to Bear Lake.
