OPTION F: RE-USE EXISTING CAMPUS



UNDER OPTION F...

- All County facilities remain at the existing campus.
- The Grove Street Annex and Bank Building are demolished, allowing a new Sherriff's Office and Jail to be constructed.
- Renovations and space reallocation occur at the existing Administration and Courthouse buildings.



- All County facilities gradually move to a remote site, possibly the Animal Control site on M-88.
- A new Sheriff's Office & Jail are constructed first, with a new courthouse and Administration building constructed in a later phase.
