# 2025 PASER Collection

Hello all,

As we prepare for the 2025 PASER data collection season, please review the following information regarding Federal Aid and Non-Federal Aid roadway condition data collection efforts across the 10-county Northwest Michigan region. A preliminary schedule for Federal Aid data collection by county is attached in this memo. This schedule is flexible and can be adjusted based on the availability and needs of each local rating team.

# 2025 Federal Aid PASER Collection

- For the 2025 season, we will continue collecting PASER ratings on 100% of Federal Aid eligible roads in the region.
- Each data collection team will include:
  - An MDOT representative (driving)
  - A County or City representative (routing and navigation)
  - Networks Northwest staff (data collection and coordination)
- Similarly to previous years the reimbursement for Federal Aid data collection will cover time, training, mileage, and meal expenses. The same reimbursement structure applies to Non-Federal Aid (NFA) data collection.

# Non-Federal Aid (NFA) Collection and Reimbursement

- No additional funding has been allocated this year specifically for NFA data collection. However, <u>if</u> remaining funds become available after the Fed-Aid ratings/reimbursements toward the end of the fiscal year (preferably late August, no later than September 1st week to accommodate the time and rating schedules), we will prioritize allocating them toward NFA reimbursements.
- If your agency is interested in performing NFA ratings, please notify us. Include:
  - An estimated number of NFA miles
  - Whether you would like assistance from Networks Northwest staff NN staff may be available to assist with NFA ratings, but please note that staff availability may be impacted by existing workload.
