MEDC's <u>Brazil and Europe office representatives</u> are coming to Michigan to meet directly with our business community February 5-9, with visits taking place in Troy (Automation Alley), Ann Arbor, and Grand Rapids (Van Andel Global Trade Center). These unique visits allow Michigan small businesses to meet one-on-one in-person with global leaders in trade to support your company's entry and expansion into European and/or Brazilian markets. Upcoming opportunities to directly engage in these markets in 2024 include the United Kingdom (UK) and Netherlands trade mission in April 2024 and the Brazil and Chile trade mission in June 2024.

Both Claudia Tomaselli (Brazil) and Terry Potter (Europe) have successfully counseled Michigan small businesses to expand their sales into their respective global areas of coverage. ### **ExporTech Winter Session**

Michigan is once again partnering with our federal partners at U.S. Commercial Service (USCS) to bring Michigan exporters the opportunity to participate in export programming. ExporTech™ is more than a seminar training. Conducted online, during six morning sessions with individualized coaching over an 11-week period, ExporTech™ accelerates a company's export strategic planning process into a concise timeframe. Michigan manufacturing, service-based exporters and technology executives are invited to apply. **A maximum of eight companies will be selected**, providing your executive team with a unique learning environment. Products and services must be 51% U.S. content.

Cohort meetings are conducted online 9 a.m.-12 p.m.: Feb. 22-23, March 26-27 and May 2-3

#### ExporTech<sup>™</sup> program highlights:

- National program developed by USCS and the National Institute of Standards and Technology's Manufacturing Extension Partnership.

- Each company is assigned a coach to navigate the strategic export sales process. Companies are matched with MSU Broad College of Business students for initial international market research.
- Peer group model drives accountability, action, learning and networking.
- Each company completes the program with an actionable strategic export sales plan.

# May 2-15: <u>Automation Alley's Trade Mission to Australia and New</u> Zealand

Hosted by Automation Alley, up to ten companies are invited to engage in B2B meetings with potential buyers on this trade mission to Australia and New Zealand. The Australia-U.S. Free Trade Agreement allows 99% of U.S. exports to enter duty-free, and a shared common culture, business practices, and legal framework reduces non-tariff barriers to export to these markets.

#### June 8-14: GSGP's Trade Mission to Brazil and Chile

Join the MEDC and the GSGP for a multi-sector trade mission to São Paulo, Brazil and Santiago, Chile. These countries are strong U.S. trading partners and Brazil is home to South America's largest consumer market and GDP. Because these markets have complex regulatory and tax frameworks, leverage this opportunity to enter the market with assistance from Michigan's knowledgeable in-country trade experts.

#### June 17-21: <u>Trade Mission to Eurosatory</u>

Join the Michigan exhibition within the U.S. Pavilion at Eurosatory 2024 and connect with defense and homeland security professionals from around the world. Eurosatory features all products and components in the air and land defense and security supply chains.
